- **Age Limit:** As on 25/09/2025 not exceed 50 years can apply. Retired Ayurveda Therapists below the age of 60 years are allowed to apply.

- Eligibility Criteria: Diploma / Certificate in Ayurveda Pharmacist Course from approved Universities recognized by the Govt. of Kerala.
