**DETAILED VACANCY CIRCULAR**

Applications are invited from the eligible officers for filling up the post of **Assistant Professor (Agriculture Chemistry) [Re-designated as Assistant Professor (Chemistry)]**, a General Central Service, Group 'A' Gazetted, Non-Ministerial post in Level-11 of the Pay Matrix at National Sugar Institute, Kanpur – a subordinate office of the Department of Food & Public Distribution, Ministry of Consumer Affairs, Food & Public Distribution, by Composite Method: Promotion/ Deputation (including short-term contract). Details of the post, eligibility conditions etc. (As per the English version of RRs notified vide G.S.R. No. 255 dated 30/07/2019) are given in the **Annexure-I**.

2. Applications of only such officers/ candidates will be considered as are routed through proper channel and are accompanied by: -


(i) Bio-data (as per the proforma given in **Annexure-II**) – each page of the Bio-Data and all supporting documents to be attested by an officer not below the rank of Under Secretary and certified by the Employer/ Cadre Controlling Authority.

(ii) Photocopies of APARs for the last five (5) years duly attested on each page by an officer not below the rank of Under Secretary.

3. Applications of suitable and eligible officers and who can be spared immediately in the event of selection may be sent directly to the Under Secretary (SA), Department of Food & Public Distribution, Ministry of Consumer Affairs, Food & Public Distribution, (Room No. 476), Krishi Bhawan, New Delhi – 110 001 within a period of **60 days** from the date of publication of this advertisement in the Employment News.

4. Procedure for filling up the posts shall be as per guidelines issued vide DoP&T's O.M. No. AB-14017/71/89-Estt. (RR) dated 03/10/1989 and subsequent amendments issued by DoP&T from time to time.

(ii) five years' experience of research work in Agriculture Chemistry or five years working experience in cane department of sugar factory or other related industrial units or five years teaching experience at degree level in Agriculture chemistry or

(B)(i) Doctorate in Chemistry from a recognised University or Institute with essential qualifications specified above, viz.. Masters degree in Agriculture Chemistry or Masterr's degree in Chemistry with Agriculture Chemistry as one of the subject from recognised University or Institute; and

(ii) three years' working experience in cane department of sugar factory or other related industrial units or three years teaching experience at degree level in Agriculture chemistry.

Note 1.- The experience shall be considered after attaining the essential educational qualifications;

Noie 2.- The Departmental Junior Scientific Officers (Agriculture Chemistry) in level-10 Rs. 56,100-1,77,500 in the pay matrix having five years' regular service in the grade shall also be considered along with outsiders for appointment on deputation and in case such person is selected for appointment to the post, the same shall be deemed to have been filled by promotion.

Note 3.- The period of deputation (including short term contract), including the period of deputation (including short term contract) in another ex-cadre post held immediately preceding

this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed four years.

Note 4: The maximum age limit for appointment by deputation (including short-term contract) shall be not exceeding fifty-six years as on the closing date of receipt of applications.

6. Place of Posting: The place of posting will be National Sugar Institute, Kanpur (UP), but liable to be posted anywhere in India.
