# Eligibility criteria and other Important Information relating to the contractual engagement is as follows:

#### **Homeopathy Physician:**

#### A. Essential Academic qualification to be eligible for engagement is given below:

- (i) Degree in Homeopathy of a recognized University or statutory State Board or Council or equivalent recognized under the Homeopathy Central Council Act, 1973 (59 of 1973).
- (ii) Enrolment on the Central Register of Homeopathy or State Register of Homeopathy.
- B. Age Limit: Not exceeding 35 years as on date of reporting for interview. (Age relaxation as per Rules)
- C. Emoluments: Rs. 50,000/- per month (5 hours per day and six days a week). No other allowances in any form shall be admissible.

#### **General Terms and Conditions**

#### **Terms of Contract:**

- 1. The above engagement will be purely on a part time contractual basis and shall be valid for a period of one year subject to work performance and accepted by either parties or appointment of regular incumbents whichever is earlier.
- 2. The contractual engagement may be terminated / discontinued on either side giving one month prior notice to this effect without assigning any reason.
