2. Eligibility Criteria:

A candidate as on the last date of receipt of online application;

- **A)** Must be graduate with diploma/degree in Library Science from a recognized University.
- B) Desirable: Knowledge of Computer Applications in a Library.
- **C)** The candidate must possess valid Employment exchange registration number for the State of Assam.

Final Selection will be made on the basis of total marks obtained in Stage I and Stage			

Final Selection will be made on the basis of total marks obtained in Stage I and Stage II. Where more than one candidate obtains same grand total marks, the candidate who obtains more marks in the written examination will get preference. Where the marks obtained by such candidates in the written examination are also same, then the candidate who is senior in age will get preference.

5. **HOW TO APPLY:**

Before applying online, candidates must possess a valid e-mail ID and Mobile Number which are mandatory for registration. E-mail ID should be kept active. Though the system is designed to send e-mail immediately acknowledging the Registration Code, sometimes due to network congestion, the e-mail may not be delivered, hence the candidates are requested to note down the Registration Code.

- **III.** Candidates need to upload following testimonial (s)/certificate (s) at the time of submission of online application.
 - **a)** Age proof document (Class X admit card/Pass Certificate/Date of birth certificate),
 - **b)** Degree/Diploma in Library Science (Pass certificate/ Final Consolidated Marksheet).
 - c) Caste certificate
 - **d)** Disability certificate from competent authority, applicable only for PwBD candidates.

It is to be noted that candidates have to produce all their original testimonials at subsequent stages when asked for, No modification/alteration of applications once submitted will be entertained at later stages

Fee once paid shall not be refunded under any circumstances. The fee will also not be held in reserve for any other examination or selection.

8. TERMS AND CONDITIONS:

- i. Number of posts shown above is indicative only and may vary at the time of final selection.
- **ii.** Merely satisfying the eligibility criteria will not entitle a candidate to be called for the written test/ Interview/Viva-Voce etc.
- iii. No person, who has entered into or contracted a marriage with a person having a spouse living or who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the aforementioned posts.
- **iv.** The admission of candidates at all stages of the selection process shall be purely provisional and subject to their satisfying the prescribed eligibility criteria. If, on verification at any time before or after the selection process, it is found that a candidate does not fulfil any of the eligibility conditions, his/her candidature shall stand cancelled without any notice. Mere calling of candidate to written

examination/ Interview etc. or issuance of admits cards/call letter etc. does not mean acceptance of candidature of any candidate which shall be further scrutinized at every stage and the High Court reserves the right to reject the candidature of any candidate at any time.
