5. SPORTS ACHIVEMENTS: -

- (a) Basketball: Basketball Federation of India is only recognized National Sports Federation for the game of Basketball recognized by Ministry of Youth Affairs & Sports.
- (b) Archery: Performance/Achievements and certificates issued by the recognized National/International Sports bodies, by Railway Sports Promotion Board, will only be considered for the purpose of recruitment.
- (c) Athletics: Medal winning performance in National/ Inter State Senior or Junior Athletics Championship, may be considered for recruitment against the posts having grade pay Rs.1800/- in pay band Rs.5200-20200/-.

- (e) Cricket (Men): Quarter Finalist in Senior/U-25/U-19 All Indian Inter State Elite Group Championship (Except Plate groups) & All India Inter State Championships and Participation in Senior/U-23/U-19 All India Senior Inter-Zonal Champinship.
- (f) Football (Men): The condition of mandatory quota for Under-21 players in Santosh Trophy has been excluded.
- (g) Golf (Men): Sports persons having I.G.U. ranking upto 100, subject to single handicap i.e. less than 10 (in order of Merit/Amateur Merit list) shall also be eligible for recruitment. Only the current Annual All India Ranking shall be considered for these purposes. The highest ranking in the year of recruitment may be considered for the purpose. The players may be allowed to play in professional tournaments only after completing 5 years after recruitment after taking NOC from RSPB.

6. MINIMUM EDUCATIONAL QUALIFICATION: -

The candidates should possess the following Educational/Academic qualifications as on the date of closure of the application.

7. <u>AGE LIMIT: -</u>

The sports achievement of current & previous two financial years will be taken into account for eligibility. Therefore, the Sports Achievement on or after 01/04/2023 will only be considered.

Note: - Certificate in proof of the above relaxation in applications fee, issued by the authorities authorized to issue such certificate, should be enclosed along with the applications form for getting exemption from paying this fee (Format attached).

10. <u>SELECTION PROCEDURE</u>: -

Selection will be based upon performance in Sports Trial and Interview and Certificates produced in support of Educational qualification and Sports Achievements and finalized by a nominated Selection Committee. Sports achievements of current and previous 02 (two) years i.e. 2023-2024, 2024-2025 & 2025-2026 shall be taken into account in terms of Para 4.2 of RBE No.189B/2010. Therefore, sports achievement on or after 01/04/2023 shall only be considered for deciding their suitability in the Trial and further process. For this purpose, concluding day of championship shall be taken into account.

Further, it is also bring to the notice of all concerned that, in the event of non-availability of suitable candidates, with required sports achievements, for consideration for appointment in Level-5 posts, as notified, candidates also can be considered in lower Group 'C' categories to the extent of the notified posts and subject to their overall suitability in the said discipline.

The Venue & Date of Trials and Interview/Certificate Verification will be intimated to the eligible candidates. Candidates are advised to visit CLW official website regularly for latest updates and further information. Shortlisted eligible candidates will be called for: -
